

**10<sup>th</sup> Anniversary – 4 night Tuscany Getaway in Italy for Two People**

**Complete Contest Rules and Regulations**

1. For every purchase of a “Qualifying Product” at participating Fresh St. Market stores in British Columbia during the contest period, you will automatically receive an entry form at the check-out printed on your purchase receipt.
2. Qualifying Products change each week of the contest and are advertised in the Fresh St. Market flyer, online (website, social media pages), and in stores.
3. To enter, fill out the entry form by hand and deposit it in the specially marked entry box at participating Fresh St. Market stores in British Columbia, before the store closing time on November 9, 2023.

5. All entrants must correctly answer the skill testing question on the entry form in order to be eligible to win a prize.
6. Odds of winning prize are dependent upon the total number of eligible entries received from all participating Fresh St. Market stores in British Columbia. A total of one (1) prize is available: One (1) four-night stay at the Relais Il Falconiere in Tuscany, Italy for two (2) people, which consists of the following:
  - (a) Round-trip Economy class flights for two (2) people from Vancouver, Canada to Florence, Italy;
  - (b) Four (4) nights (in total) accommodation at Relais & Chateaux Il Falconiere (Cortona, Tuscany), Double Room;
